"Why was Kyle's medication kept from him, and locked in his father's truck? Why was the gun not locked in the truck with the medication if Brennan was concerned for Kyle's safety?

"According to his Mother, Kyle would not willingly give up his medication. He had openly discussed with his uncle before arriving in Tampa his fear of running out of the medication. He expressed relief that this would no longer be a concern as he could refill the prescription. Kyle also understood the necessity of taking it daily as he came to realize that this would help stop some of his erratic behavior.


Obviously, some of the inquiries are not difficult, but some are critical and my client wants me to move forward in an effort to help her deal with this. Please let me know.
