MAJOR TARGET:

VITAL TARGETS:

OPERATING TARGETS:

1) Mayor was at L.A. City College during 1938-40. He would have been 18 to 20 years old. This was before he was in the Army. Document that he was in LA during this time. Liaison with IAC SEC on this.

2) Ascertain exactly, admin wise, what would have happened in 1940 if an american got married to a mexican girl, in a border town like Tijuana. Who could have married them/ a lawyer? a priest? a Court official?

What would have happened to the license? Would the license stay in the town with a copy sent to the State's Capitol or to Mexico City? Would a copy always have been sent to the US Records Bureau? Would the Police have gotten a copy. Do any other Mexican Bureaus have records of this sort of thing. Or was it simply take care of by a record in a Bible.

The idea here is to ascertain what records would exist if an American were to have gotten married in Tijuana in 1938-40, and where these records would be now.
